3. The Society / School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
4. The School shall not deny admission to any child
 - (i) For lack of age proof.
 - (ii) If such admission is sought subsequent to the extended period of 90 day for admission.
 - (iii) On the ground of religion, Caste or race, place of birth or any of them
5. The School shall ensure that,
 - (i) No child admitted shall be held back in any class or expelled from school till the completion of Elementary Education in that school.
 - (ii) No child shall be subjected to physical punishment or mental harassment.
 - (ii) No requirement to pass any Board examination till the completion of Elementary Education.
 - (iii) Every child completing Elementary Education is awarded a certificate as laid down under rule 19 of the Right of Children to free and Compulsory Education, Himachal Pradesh Rule,2011.
 - (iv) Student with disabilities/ special needs are given admission as per provision of the Act,
 - (v) The teacher is recruited with minimum qualifications as laid down under section 23(1) of the act. The current teacher: who, at the commencement of this Act did not possess minimum qualification shall acquire such minimum qualification by, 2015
 - (vi) The teacher performs his/ her duties specified under section 24(10) of the act, and
 - (vii) The Teacher shall not engage himself or herself for private teaching activities.
6. The School shall follow the syllabus on the basis of curriculum laid down by academic authority under-sub section (1) of section 29.
7. The school shall enroll students proportionate to the facilities available in the school specified the section 19 of the Act.
