


- Trustees for the time being shall have power from time to time, whenever they consider necessary to appoint additional trustees. The power under this sub-clause will be exercised in the meeting of the trustees by way of resolution passed by all the trustees, But the total number of trustees shall not exceed more than fifteen.
- That in the case of death of any trustee, his/her legal heir shall be automatically member of the trust. In the case of more than one legal heir, they shall choose one among themselves to be a trustee of the above trust.

VACANCIES:-

That the first trustees or any additional trustee that may be appointed heremulter will cease to be so, if at any time, they suffer form any of the following disqualifications:-

- a) if a trustee has been found to be of unsound mind by a court of competent jurisdiction.
- if a trustee is any undischarged insolvent. b)
- if a trustee has applied to be adjudicated as an insolvent and his c) application is pending.
- if a trustee has been convicted by a court of an offence involving d) moral turpitude.
- If a trustee resign from the trusteeship of the trust. el

VI. OBJECTS OF THE TRUST:

The objects of the trust are as under:-



- Any other object of general public utility not involving the carrying on of any activity for profit.
- The above objects shall be open for the benefit of all persons belonging to whatever community irrespective of caste, creed & religion.

VII. POWER, RULES & REGULATIONS OF THE TRUST:-

The trustees shall stand possessed of the said amount of cropus and such other properties (both moveable and immoveable) as may be acquired from time-to time by the trust by purchase, exchange, grant, subscriptions, endowment, donation, contribution or in any manner whatsoever (all of which shall be designated as "the trust properties". on the trust herein mentioned) from other persons, commercial firms, institutions, organifations, State and Central Government and Local Bodies.

The trust shall have power to accept donations either in cash or moveable properties either with or without any special conditions attached to it provided it do not contravene aims and object of the trust, as provided in Clause VI hereinabove.

3. It shall be competent for the trustees from time to time to frame, make and enforce all such rules, regulations and/or by-laws, not inconsistent with the express provision is trust, as the trustees may deem proper for and the man one to the Land and management in details of

- 4. - 7. Trustees shall not be entitled to any remuneration and shall work in an honorary capacity they shall however, be entitled to receive the reimbusement of expenses incurred by them in the course of discharging the fact that is as trustees of the trust.

- The trust shall be governed by a Board of Trustees. The Board of Trustees shall consist of all the trustees the number of which shall always be not less than five and not more than fifteen.
- The trustees may elect or nominate one of them as the Chairman, Managing Trustee and Hony. Secretary of the Board of Trustees. The Chairman, Managing Trustee and Hony. Secretary may be appointed for any period of time notwithstanding anything contained in this instrument.
 - 10. The Board of Trustees is hereby authorised and empowered to nominate any other person as trustee as long as the trustees do not exceed fifteen in

The trust may at any time invite and receive or without such invitation receive any voluntary contribution or contributions either from the settlor or from the trustees or from any one or more of them or from any other person or persons by way of donation, legacy or otherwise. All such contributions shall be treated as forming part of the trust fund being the subject matter of these presents provided that it shall always be for the frustees in their absolute discretion to decide whether to invite and/or accept any such contribution without giving any reason for such refusal.

12. The trustees shall have power to deposit the trust moneys or any portion thereof in any Nationalised bank or Banks either by way of fixed deposit or in current account or saving account. The operation of bank account shall be conducted by the trustees as may be decided from time to time.


13. The trustees shall also have power to invest the trust money in Govt. Securities or in any other approved manner and also to invest in such manner as may be directed by the Board of the trustees, and from time to

time vary the investment in which the trust funds may be invested. wind from aires (18050)

shall have power to acquire by purchase or on lease or otherwise immovable properties of any tenure and in case of vacant land the trustees shall be at liberty to erect buildings thereon and to do all acts necessary and incidental thereto.

- 16. It shall be lawful for the trustees to pull down, renovate, rebuild, alter, adopt, improve, add to develop or repair any immovable property comprised in the trust properties and to spend thereon such moneys out of the trust fund or the income thereof as they may think fit.
- 17. The trustees shall be entitled to enter in any agreements or convenants with the owners fo or persons entitled to or interested in any other properties and to raise funds by way of loans.
- 18. It shall be lawful for the trustees at such time or times as they may in their absolute discretion think fit, to sell by public auction or private contract or exchange or transfer or asign or grant lease or sub leases for any term however, long or otherwise dispose of all or any part of the trust properties including immovable properties.
- 19. The trustees may deposit for safe custody any documents held by them selating to any property belonging to the trust under these presents with any Bank and may pay any sum payable in respect of the same.
- 20. It shall be lawful and competent for the Board of Trustees in their discretion to make donations from the trust properties and/or send the moneys of the frust in their discretion in any other manner to carry out the objects of the trust and not contravaning object clause hereinahvoe.

The entire control, regulation, management, application and administration of the trust properties whether capital or income, rent, interest or profit of any shall be in the discretion of the trustees.

- 23. In case of difference of opinion arising among the trustees and in all matters wherein the trustees shall have a discretionary power the opinion of the two third majority of the trustees present on voting shall prevail and be binding upon all the trustees.

25. MEETING:-

- i) The trustees will appoint a Chairman to preside over the meeting and determine the period for which he is to hold the office.

27. QUORUM

- No business shall be transacted at any meeting unless all the trustees or their authorised representatives are present at the time when the meeting proceeds to business.
- Save as herein otherwise provided all the trustees or their authorised representatives must be present in the meeting.
- If within half an hour from the time appointed for holding the meeting all trustees or their authorised representatives are not present, the meeting shall stand adjourned to the same day in the next week, at the same time and place.
- If at the adjourned meeting, all trustees or their authorised representative are not present within half an hour from the time appointed for the meeting, a fresh meeting to be called on any next date.
- 28. A minute book shall be kept by the trustees, minutes of the entry into office of every new trustee and of all proceedings of the meeting of the Board of Trustees shall be entered in the minute book.
